I am a Police Constable in the Cleveland Police presently posted to the Licensing unit at Middlesbrough Police office.

Further to my statement dated the 1st December 2017 I would like to add the following information.

At 8:58pm on Thursday 7th December 2017 a call was made to Cleveland Police about a male who had been assaulted in Manhattans.

The caller claimed that the victim had facial injuries and has had his head stamped on.

The assailant was arrested after leaving the scene and was later charged with common assault.

Event E222157 refers and I exhibit this as JRJ/11.

I have obtained the internal CCTV footage from Manhattans in relation to this incident and this shows the victim stood at the bar when a male who is sat on a seat behind him get up and walk over to the victim and without provocation, punch him on the side of the head and knock him to the floor and then stamp on him as he is laid on the floor.

The DPS comes from behind the bar and intervenes and the suspect leaves the premises.

This footage is available to view and I exhibit this as JRJ/12.

At 9:41pm on Friday 12th January 2018 a call was made from CCTV regarding a Silver Mercedes vehicle that was parked up on the High Street directly outside the premises and the occupants may be involved with drugs.

I have obtained the footage from this and it clearly shows the silver car parked on the same side of the road as the premises.

The camera pans towards the vehicle where 2 males are seen sat in the driver and front passenger seats. The time on the camera is 9.36pm.

After a short time the driver hands the passenger a small clear bag containing what appears to be powder and whilst I cannot say for certain what is in this bag, I am fairly certain it will be some kind of controlled drug.

After this transaction takes place, both males get out of the car and walk in the direction of the pub although it is unclear whether they go in.

The next part of the footage shows the same male who was sat in the driver's seat come out of the pub with a female sat following him. The time on the screen is now 10.23pm.


They both get in the car and after a short time the female leans over towards the male and she can clearly be seen snorting a substance from the male.

Again, whilst I cannot say what she has taken but in my opinion this will probably be a controlled drug.

They both leave the car and go back into Manhattans at 10.25pm.

Just over a minute later the same male comes back out of the premises with another male, different from the 1st male above and they get back into the car.

They both remain in the car for approximately 4 minutes and in that time the male in the passenger seat is seen going through his own pockets in what appears to be looking for money before the driver hands over another small clear bag containing a white substance.

They both get out of the car and the driver walks into the premises but the male passenger talks to a male who may be a member of doorstaff.

A Police vehicle pulls up and as the officers get out the male who was sat in the passenger seat goes into the pub.

The Police officers enter the premises but the footage ends at this time however the driver of the car was not found at the time as at 12.16am he is seen leaving the premises in company with the female he was in the car with and he gets in his car and does a 'U' turn and drives off along Norton Road.

Police are notified of the vehicle moving off and it was located away from the town centre and the driver was dealt with for drug offences.

Whilst there is no indication that anyone connected to this premises is being complicit in these activities, the mere fact that it is taking place in public directly outside of the premises is serious cause for concern.


The footage of these activities is available and I exhibit this as JRJ/13.

At 1.43am on Sunday 21st January 2018 a call was made regarding an incident outside of Manhattans.

A male was arrested for a non domestic related Common Assault at the time.

I have obtained the footage of this incident and at the time above a male in a black T shirt is seen arguing with a female.

There is a member of doorstaff present at this time.

The male walks away from Manhattans and is seen talking to a blonde haired male who gives the 1st male his jacket.

At 1.45am the camera goes back to the premises where the female is stood outside with the doorman.

Mr Hill, the premises licence holder is also present at this time.

The blonde male walks over to the premises with the 1st male who sits against a nearby parked car.

The blonde male talks to the doorman and then throws a punch at him which I believed strikes him on the chest.

Mr Hill then punches the blonde male striking him on his head.

The doorman then becomes aggressive towards the blonde male and is seen following him along the footpath away from the premises. He is seen kicking out at the blonde male and putting his fists up in a boxer's stance as he moves towards him.


The blonde male backs off but the doorman follows him with the female and another male trying to hold him back.

At 1.46am a Police unit arrives and eventually the blonde male is arrested.

He is taken to custody but is released, no further action, due to the female refusing to make an official complaint.

There is no complaint made by the doorman or anyone else present at the time of this incident.

I believe the doorman's actions following the initial punch were out of context with the situation.

To follow him along the path acting more the aggressor than the person who has struck him is not what would be expected of a door supervisor.



I am employed by Stockton-on-Tees Borough Council as a Licensing Officer, based within the Licensing Unit located at in Municipal Buildings, Church Road, Stockton on Tees. I have held this role for over 23 years and I am responsible for the administration and enforcement of the Councils miscellaneous licensing functions.

On 17 November 2017 I attended Manhattans with PC 190 Johnson from the Licensing Unit at Cleveland Police. The purpose of the visit was with regard to enquiries relating to an allegation of an assault which had taken place on 12 November in the early hours of the morning.

CCTV was reviewed on site by myself and PC Johnson in the company of Malcom Conner who is employed at the premise as a Door Supervisor and Barman. The footage from the CCTV clearly shows that camera 7 which covers the area known as the VIP Lounge is deliberately moved from facing the area it is supposed to cover, to being turned 180 degrees to face the ceiling. This happens at around 02.18 and 02.19.

CONTINUATION OF STATEMENT OF: Craig Paul Barnes

The camera is positioned on the wall near to the entrance to the stairs leading down to the toilets in the basement area. The camera is at around 3.5m from the floor and cannot be moved in that manner without using ladders or climbing on other fixtures in the location to reach it.

It was suggested by one staff member that it had been knocked with the end of a pole as they were turning light switches off in the location. In my opinion this would be very unlikely and if accidentally touched it would have been repositioned.

Camera 5 was also viewed and this showed people leaving the premise well after the closing time of the premise which is 01.00hrs. This camera is showing the bar area near to the main entrance/exit of the premise.

The footage we had viewed was then requested to be downloaded onto media by PC Johnson for collection at a later date. I was advised by PC Johnson that the footage had been downloaded onto a USB Flash Drive by Mr Conner, but upon viewing the USB Drive no footage was recorded and the drive was blank.
