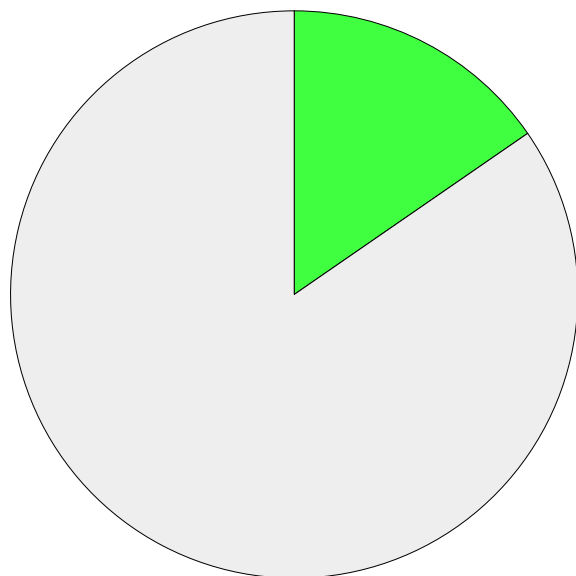

Do you agree we continue to encourage the installation of internal CCTV?

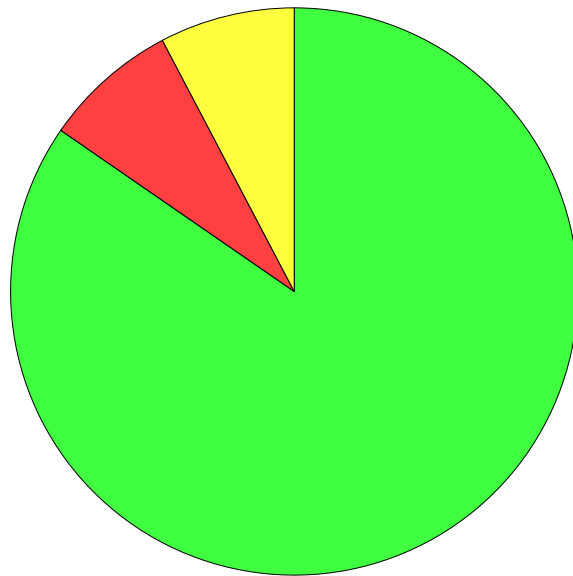

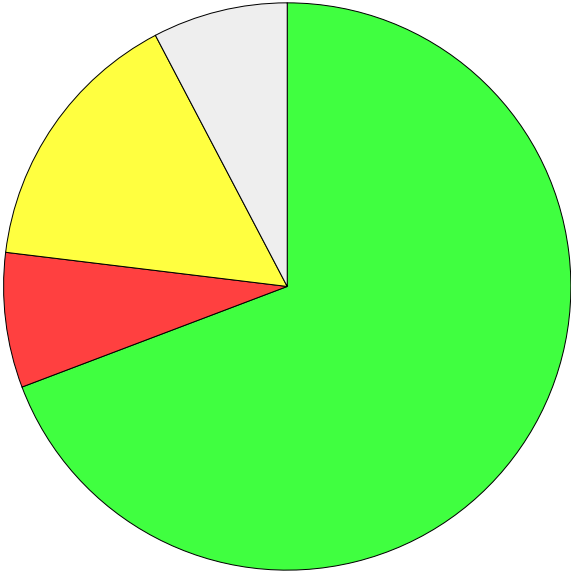

Do you agree payment of fees shall continue online and via telephone?

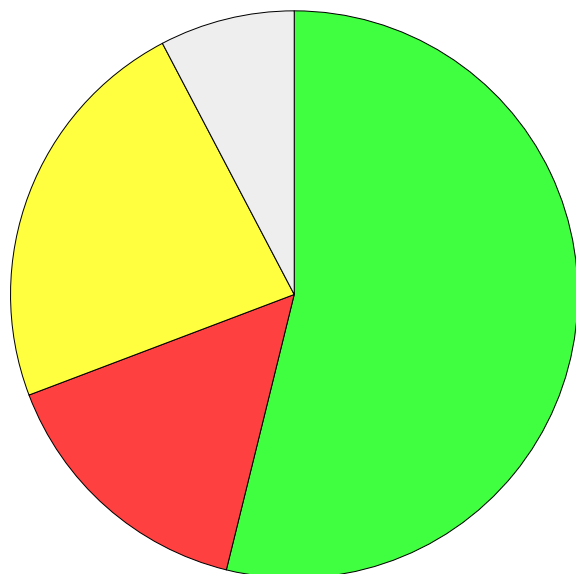

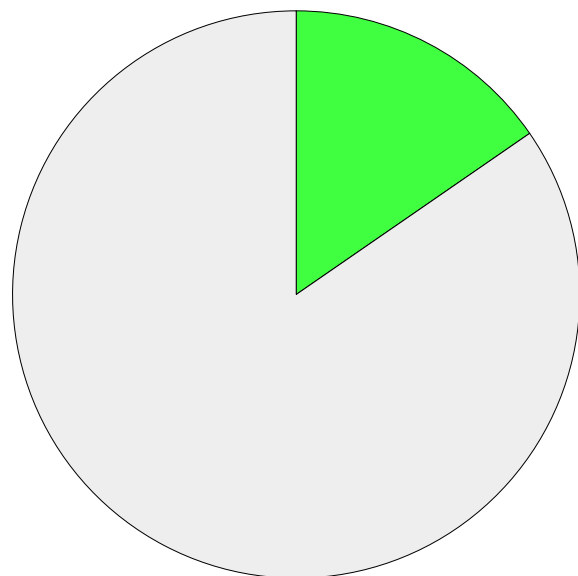

Do you agree or disagree that the policy includes everything you think should be in such a policy?

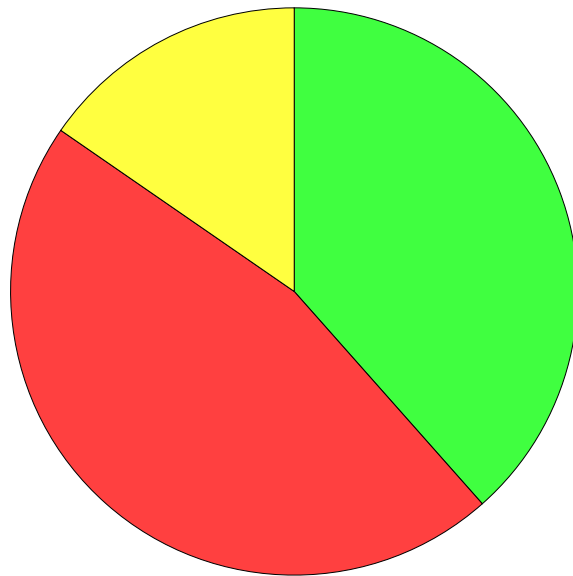

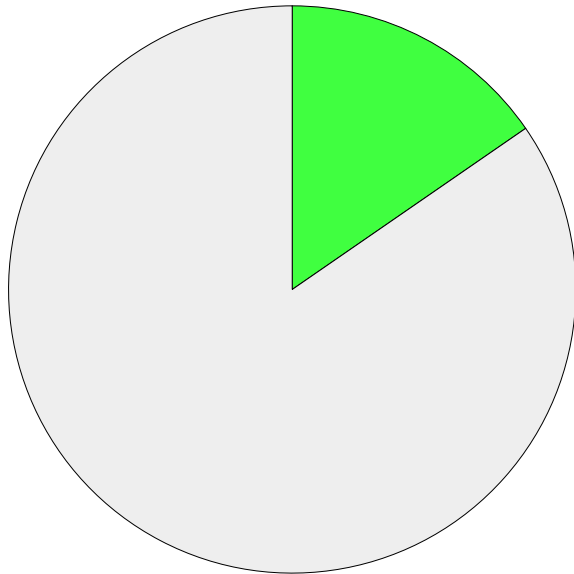
